



Corporate Counsel Attorneys May Now Provide Pro Bono Legal Services in Ohio

he Supreme Court of Ohio recently passed an amendment allowing attorneys with corporate counsel status to provide direct pro bono legal services to persons of limited means or charitable organizations. Prior to this amendment, attorneys admitted to practice in Ohio under corporate counsel status were only allowed to perform legal services for their employer. Now the path has been cleared for some 300 in-house attorneys to help fill the pro bono services gap in Ohio and utilize their legal skills to engage with individuals and non-profits in the Greater Cincinnati area through pro bono service.

The caveat to this expansion is that the pro bono work must be assigned to the corporate counsel attorney by an approved pro bono provider. Locally, the Cincinnati Bar Association, Volunteer Lawyers Project, and Pro Bono Partnership of Greater Cincinnati are all approved pro bono providers.

Since the amendment became effective on April 1, 2015, the Pro Bono Partnership of Greater Cincinnati has already had several corporate status attorneys from in-house legal departments volunteer to represent nonprofits with their business legal needs. From Rule VI, Section 3(E) of the Rules for the government of the Bar of Ohio:

Section 3(E): Pro bono legal service.

[A]n attorney registered for corporate status under this section may provide pro bono legal service if the legal service is provided to either a person of limited means or a charitable organization and the legal service is assigned or verified by any of the following:

- An organization receiving funding for pro bono programs or services from the Legal Services Corporation or the Ohio Legal Assistance Foundation;
- 2. A metropolitan or county bar association;
- 3. The Ohio State Bar Association;
- 4. The Ohio Legal Assistance Foundation;
- 5. Any other organization recognized by the [CLE] Commission
