Sweet Cheeks Diaper Bank

Sweet Cheeks Diaper Bank partners with local social service agencies to provide free diapers to low-income families while raising awareness of the basic health need for diapers. Their vision is to eliminate the existence of diaper need in our community so that all babies have a chance to be healthy, happy, and safe. They've grown exponentially since they started distributing diapers in April 2016, and are currently sending out nearly 150,000 diapers each month to 41 partner agencies in Greater Cincinnati, with 30 more agencies currently on their wait list.
