Our main program service is our direct legal representation of qualifying 501(c)(3) organizations in connection with their business legal needs. This is accomplished by making it easy for in-house and law firm transactional attorneys to volunteer on behalf of these organizations within their own areas of expertise. In 2018, PBPO provided free legal assistance to 120 nonprofit organizations. With 268 volunteer attorneys were matched with 334 different legal matters for nonprofits. Volunteer attorneys provided free legal assistance to PBPO clients valued at over \$715,000. Additionally, in 2018 we also provided 28 educational outreach seminars, workshops, and legal checkup events to nonprofit leaders and board members in Cincinnati and Dayton.
