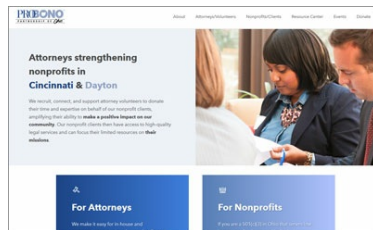

## PBPO's Response to COVID-19

PBPO quickly mobilized our small staff to support and respond to new needs in the nonprofit community during this challenging time. In the past few weeks, we have:

- Established an [Employment Helpline for COVID-19 Rapid Response](#) offering 30-minute consultations with attorneys to address critical, time-sensitive needs;
- Published multiple, timely [Legal Alerts](#) updating nonprofits about the CARES Act, role of board governance in times of crisis, changes in contract and labor regulations, and much more;
- Co-hosted a free webinar with the [United Way of Greater Cincinnati](#) focusing on emerging COVID-19 legal issues for nonprofit employers;
- Created a COVID-19 designated page on our [website](#) with current and relevant legal resources for nonprofits.

During this time, our operations have continued without interruption as we work together to face the challenges this pandemic has brought to our entire community.

## \$50,000 Grant for COVID-19 Rapid Response

PBPO is thrilled to share we were awarded a \$50,000 grant from the [Greater Cincinnati Foundation \(GCF\)](#) and [United Way of Greater Cincinnati's COVID-19 Regional Response Fund \(UWGC\)](#). Due to the unprecedented impact of COVID-19 in our region, GCF and UWGC partnered to activate a coalition of philanthropy and business partners to create the COVID-19 Regional Response Fund.

This grant award will be used to expand our capacity to meet the legal challenges of our area's nonprofit organizations during these difficult times. PBPO will assist hundreds of nonprofits in our community, meeting the needs of thousands of our friends and neighbors, creating a ripple effect of care well beyond the abilities of any one of us alone.
