2021 CLE Credit Deadline for 2021 Pro Bono Work

If you volunteered a minimum of 6 hours with PBPO in 2021, you may be eligible to receive Ohio CLE credit. All pro bono work performed in 2021, whether or not the matter is complete, must be submitted in the 2021 reporting cycle to receive CLE credit. 'Tis the Giving Season! 2021 Charitable Giving Tax Deductions Update

The CARES Act offers several benefits through the end of 2021, most notably regarding charitable contributions. Individual taxpayers who take the standard deduction may also claim a deduction for their charitable contributions – up to \$600 for cash donations by non-itemizers to qualifying charities (like PBPO!).
