Clothes That Work's mission is to clothe, educate, and empower individuals for employment success. For 25 years, it has served the Dayton community through professional image counseling, professional development training sessions, and interview preparation for local jobseekers. An exciting new addition to the organization's services is a 38-foot mobile unit, named The W.O.W. (Wardrobe on Wheels), that will help eliminate clients' transportation barriers and improve accessibility.
