#### Reminder: 2024 CLE Credit Deadline for 2024 Pro Bono Work

If you volunteered a minimum of six hours with PBPO in 2024, you may be eligible to receive Ohio CLE credit. All pro bono work performed in 2024, whether or not the matter is complete, must be submitted in the 2024 reporting cycle to receive CLE credit.
