PBPO provides qualifying Cincinnati and Dayton nonprofit organizations with business legal services, at no cost, to help strengthen their operations. PBPO offers support in the areas of employment, governance, contracts, and more, as it addresses each organization's unique needs. PBPO also provides publications and workshops to educate the nonprofit community about relevant legal topics and make information more digestible and applicable. PBPO engages over 1,000 attorneys from corporations and law firms as volunteers. PBPO's services equip nonprofit leaders with the knowledge they need to move their important missions forward. At the same time, attorney volunteers deepen their connections to the community through their involvement. Of PBPO's \$1.61 million program expenses, the \$1,086,468 of in-kind legal services reflects the approximate value of attorney volunteers' time. In 2024, PBPO completed 499 legal projects for 201 nonprofits, with the help of 342 attorney volunteers. PBPO led 23 educational outreach seminars and published 13 Pro Bono Briefs. In total in 2024, PBPO provided an estimated \$2.1 million legal services and education for local nonprofits.
